I (WE) HAVE READ AND UNDERSTAND all of the information presented in the **Saline Varsity Blues Handbook and Standing Rules** pertaining to our membership in the organization. These documents are available online at:

My parent(s)/guardian(s) and I understand the time commitment, financial obligations, and dates involved.

I (WE) HAVE READ AND UNDERSTAND the **Handbook and Standing Rules** and I (we) agree to make Saline Varsity Blues activities a priority. I (we) understand the Attendance Policies, including my responsibilities as a VB Member, and the Attendance Consequences. I (we) understand the Behavior Policies, the Financial Obligations, and Financial Consequences should those obligations not be met.

I (WE) AGREE TO ARRANGE MY/OUR COMMITMENTS AND SCHEDULE to participate in all Saline Varsity Blues functions including rehearsals, mandatory meetings, Retreat, Fundraisers, Tour, Production/Rehearsal Weeks, Holiday Show Week (including Show and Strike), Summer Show Week (including Show and Strike) and other scheduled performances of which I may be notified, in advance, during the year. If, because of medical conditions, my/our participation becomes impossible for any event (other than fundraising), or because of a last minute conflict with a rehearsal (other than work), I (we) will notify the VB Attendance Officer. If the VB Attendance Officer approves a request for absence, in consultation with the Director and the VB Board President, in their sole discretion (no approval will be given for a conflict in a work schedule or for fundraising activities), the absence will be excused. These requirements are outlined in the **Handbook and Standing Rules**.

I (WE) AGREE TO PARTICIPATE IN FUNDRAISING. My family (including at least one adult) will contribute and participate as required. I (we) understand the consequences should these responsibilities not be met, as outlined in the Attendance Policies of the **Handbook and Standing Rules**.

I (WE) AGREE TO PAY Saline Varsity Blues the amount of approximately \$1350.00 to cover dues, the cost of Retreat, Tour and two (2) show shirts. Payment schedules will be available at the Annual Meeting. I (we) understand that NO REFUNDS for dues or tour will be issued to our family, in the event that I (we) elect to terminate membership or are expelled from Saline Varsity Blues.

I (WE) AGREE to treat Saline Varsity Blues Members, Director(s), Board Members and Parents of members with respect and in a manner in which I (we) would like to be treated.

I (WE) AGREE TO CONDUCT MYSELF in a manner worthy of the group. I (we) will comply with the rules at all times. I (we) understand that my behavior outside the group can affect the reputation of Saline Varsity Blues, and if problems arise, I (we) may be asked to come before the Saline Varsity Blues Board of Directors. Depending on the severity of the circumstances, disciplinary actions up to and including immediate expulsion from Saline Varsity Blues is at the sole discretion of the Board of Directors and may be instituted without a parent meeting. I (WE) understand that the Saline Varsity Blues organization may use my child's photograph and/or name to promote the program and/or their activities.

IF I (WE) CANNOT FULFILL the terms of this Contract, I (we) understand that I (we) have shown reason to question my commitment to the group. I (we) understand that this may be grounds for expulsion from Saline Varsity Blues.

IF ANY POINT(S) OF THIS CONTRACT REQUIRED CLARIFICATION, I (we) have asked questions and received a satisfactory answer from a Saline Varsity Blues Director or Board Member.

PARENTS(S)/GUARDIAN(S): I (we) have hereby received and read the **Saline Varsity Blues Handbook and Standing Rules** and this Contract. I (we) understand what is expected from us.
